

## APPENDIX No. 2

to the Rules of the International Architecture and Landscaping Competition FORT'S NEW LIFE for the development of a conceptual design of an Administrative Centre in Zielonki near Fort Marszowiec with landscape design

*According to Article 13(1) and (2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), this is to notify you that*

- 1) the **Controller** of your personal data will be the Hugo Kołłątaj University of Agriculture in Kraków, al. Adama Mickiewicza 21, 31-120 Kraków.
- 2) The University of Agriculture has appointed a data protection officer available at [iod@urk.edu.pl](mailto:iod@urk.edu.pl);
- 3) Your personal data will be processed for the purpose of the International Architecture and Landscaping Competition Fort's New Life for the development of a conceptual design of an Administrative Centre in Zielonki near Fort Marszowiec with landscape design, including but not limited to a public announcement of results of the competition. They may also be used in a research monograph by Magdalena Wilkosz-Mamcarczyk, Michał Uruszczyk, Julia Gorzelany, and Anita Kukulska-Kozieł pursuant to your consent, in accordance with Article 6(1)a of the regulation. Your personal data may be used to notify you about future contests if you grant a separate relevant consent.
- 4) The provision of your personal data is voluntary but necessary to participate in the competition. If you do not provide your personal data, you may not enter the competition.
- 5) You have the right to
  - a) access, rectify, erase, restrict the processing of the personal data;
  - b) data portability;
  - c) object to processingin cases and under conditions specified in the regulation;
- 6) If data is processed pursuant to a consent granted to the Controller, you may **withdraw the consent** any time, which does not affect the legitimacy of the processing based on the consent before it is withdrawn. The withdrawal may be sent by e-mail to [arch.land@urk.edu.pl](mailto:arch.land@urk.edu.pl) or by mail to Katedra Gospodarki Przestrzennej i Architektury Krajobrazu, ul. Balicka 253C. 30-198 Kraków or the consent may be withdrawn personally at the office of the Chair for Spatial Management and Landscape Architecture at 253C Balicka Street. 30-198 Kraków  
The withdrawal of the processing consent is tantamount to the withdrawal of your work from the competition.
- 7) Your personal data will be made accessible to other recipients. The recipients of your personal data will be the Municipality of Zielonki and the Ministry of Science and Higher Education.
- 8) Your personal data will be processed until the adjudication of the competition and then until the completion of the International Architecture and Landscaping Competition, until the end of service provision, until the winner is announced, and if you consent to notifications about future competitions, until the consent is withdrawn.
- 9) You may lodge a complaint with the competent supervisory authority, the President of the Office for Personal Data Protection in the case of a justified suspicion that the Controller processed your personal data at variance with the regulation.
- 10) Your personal data will not be processed by automated means, including by profiling.
- 11) Your personal data will not be transferred to a third country or an international organisation.
